SECTION 4: First aid measures

4.1. Description of first aid measures

- First-aid measures after inhalation : If inhaled and if breathing is difficult, remove victim to fresh air and keep at rest in a position comfortable for breathing. If you feel unwell, seek medical advice.
- First-aid measures after skin contact : Wash skin thoroughly with mild soap and water. Take off contaminated clothing and wash it before reuse. Get medical attention if symptoms occur. After contact with the molten product, cool rapidly with cold water. Do not tear off solidified product from the skin.

4.2. Most important symptoms and effects, both acute and delayed

- Symptoms/effects after inhalation : Dust of the product, if present, may cause respiratory irritation after excessive inhalation exposure.
- Symptoms/effects after skin contact : Not expected to present a significant skin hazard under anticipated conditions of normal use. Risk of thermal burns on contact with molten product.
- Symptoms/effects after eye contact : Dust contact with the eyes can lead to mechanical irritation. Risk of thermal burns on contact with molten product.
- Symptoms/effects after ingestion : Not expected to present a significant hazard under anticipated conditions of normal use.

SECTION 5: Firefighting measures

5.1. Extinguishing media

- Suitable extinguishing media : Dry powder. Carbon dioxide. Water spray. Foam. Use extinguishing agent suitable for surrounding fire.
