SECTION 4: First aid measures

4.1. Description of first aid measures

First-aid measures after inhalation : If inhaled and if breathing is difficult, remove victim to fresh air and keep at rest in a position comfortable for breathing. If you feel unwell, seek medical advice.

First-aid measures after skin contact : Wash skin thoroughly with mild soap and water. Take off contaminated clothing and wash it before reuse. Get medical attention if symptoms occur. 4.2. Most important symptoms and effects, both acute and delayed

Symptoms/effects after inhalation : Dust of the product, if present, may cause respiratory irritation after excessive inhalation exposure.
