Description

Luban RP4225M is manufactured using the Spheripol Technology. Luban RP4225M is a polypropylene random copolymer, with slip and anti-blocking additives. It is typically used for manufacturing high transparent cast films. This grade is recommended for packaging of foodstuffs, packaging of books and stationery as typical applications. Luban RP4225M exhibits high clarity, high gloss and heat weldability.

Storage and Handling

Luban RP4225M must be protected from direct sunlight and should be stored in a shaded and completely dry area. During handling and processing, the material should be kept in a well-ventilated area to prevent the accumulation of dust and fumes.
