Luban HP1151K is a nucleated homopolymer polypropylene for high transparency thermoforming applications with enhanced optical appearance. The product provides enhanced process ability with excellent isotropic shrinkage control.

Thermoform containers mainly for food and health drink products such as cups, trays and lids.
