## Linear Low Density Polyethylene

### Description

Luban HPR3518CB is metallocene LLDPE grade made using Hexene co-monomer. Films made using this grade has outstanding tensile properties with very good impact and puncture toughness. These superior properties along with excellent draw down capability makes this grade versatile for mono-layer and multi-layer cast film applications.
